91,136 children and community members received training to prevent trafficking and abuse.

2,146 women and girls were strengthened against human trafficking through income-generation, seed-funding, life skills training, and counseling.

445 women and girls received shelter, counseling and vocational training so they can focus on building lives of freedom and dignity.

304 girls and women, plus 25 men and boys, were rescued from slavery or
